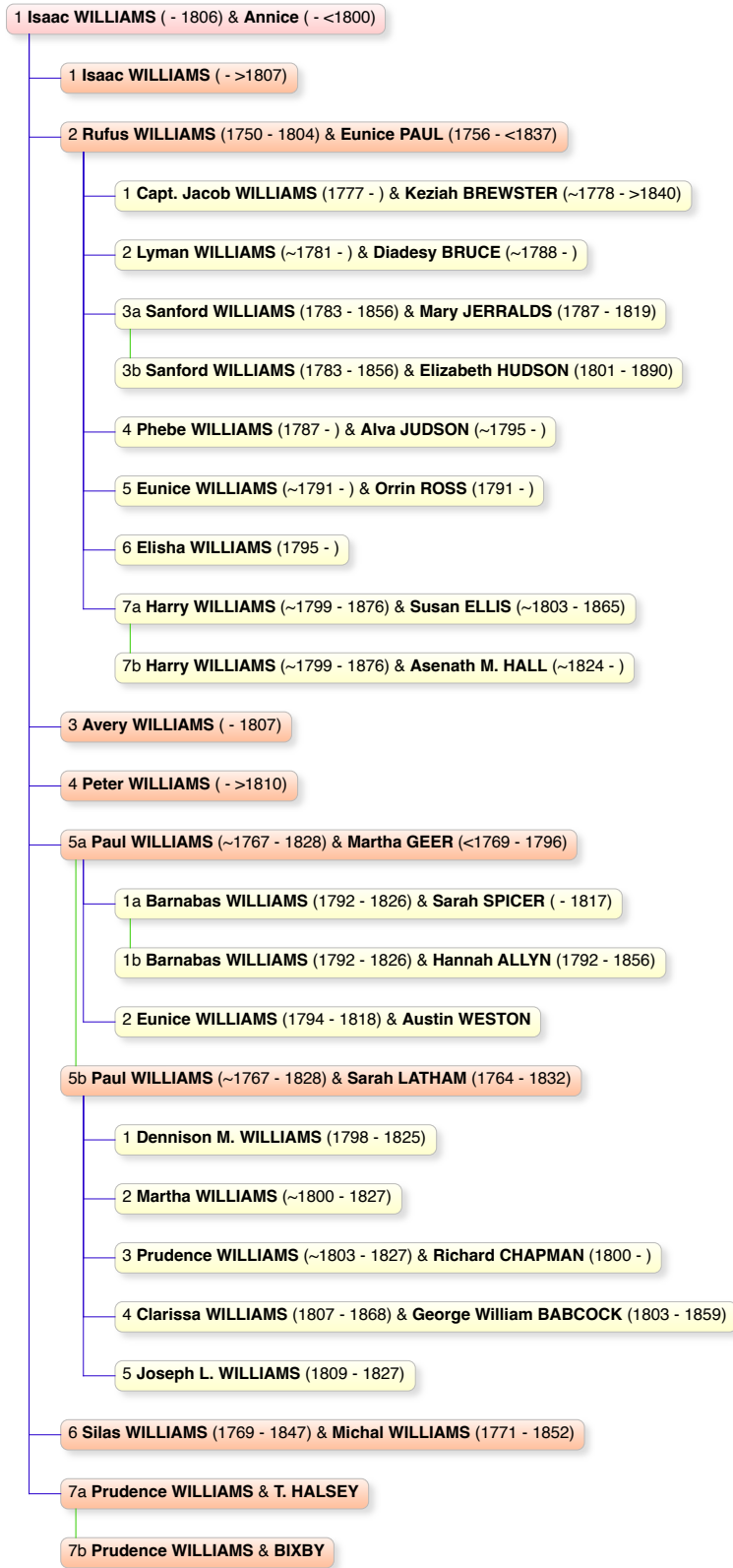

- Name given as Isaac. Lived in Ledyard, now [sic] Groton, Conn.¹
- Possibly from Westerly, R. I. - boundary dispute between R. I. & CT not settled until 1728.¹³⁹⁵

Research: • Look for in 1790

- 1800 Census: Groton, New London, Connecticut. 00010/00100. Perhaps the correct family; the only Isaac Williams in Groton, but he may be too young. Perhaps this is his son, Isaac.⁶³⁴⁹
- Perhaps Isaac is this Richard.⁷⁷³²

General: • Ledyard is a town in the southeastern part of Connecticut that, although it is predominantly rural in part, is rapidly becoming suburban in character. Bordered on the West by the Thames River with its gently rolling, tree covered hills and occasional outcroppings of ledge, it stretches off the east bordering Mystic and Stonington, and is approximately 40 square miles in area. Originally Pequot Indian territory, the first land grants to the early settlers were assigned as part of New London territory. In 1705, land on the eastern side of the Great (Pequot) River became the independent town of Groton within which the present boundaries of Ledyard exist. Early land records and legal transactions referred to this location as Groton until 1836, when the residents of this part of the North or Second Society of Groton incorporated and took the name of Ledyard. The town was named after Colonel William Ledyard, who was the commander of the Colonial forces that defended Fort Griswold in 1781 at the Battle of Groton Heights.²²¹¹

- This book is an attempt at the early family records of William Williams of New London, Conn., but is incomplete [since] many of the early records were destroyed by war and fire during the War of the Revolution, the Battle of Groton

Heights, etc. Moreover, so many by the name of Williams came into New London County and settled at New London, Groton, Stonington, Norwich and Vicinity at about the same dates, several Families using the same names for their children, even in the same town, and especially as often no Family records were kept, it has been very difficult to collect the facts from descendants, or even to find many of them.

The author has worked on this problem for over 40 years. Some of the descendants of Robert Williams of Roxbury, Mass. came into Connecticut and settled at Stonington and Pomfret, Conn., and many other Connecticut Towns, and intermarried with descendants of William Williams of New London County. Wheeler's *History of Stonington, Conn.*, gives descendants largely of Robert Williams of Roxbury.

Then after the War of the Revolution scores of descendants by the name of Williams removed to New Hampshire, Vermont and Massachusetts, New York State, the Western Reserve in Ohio, to Pennsylvania and even farther west.⁹⁴

- “Chotty’s” notes indicate no proof of the parentage of Paul, Rufus and Prudence.¹³⁹⁵

- In Abby Hemenway’s Vermont Historical Gazetteer, there is an excerpt on the history of Huntington, Chittenden county, with the following quotations:

“...settlements were begun about 1788...John Thomas and Rufus Williams,...made each their pitch on the east Hill — the one north and the other east of John Martin, and both adjoining his.”¹⁴⁰⁶

“...Rufus Williams was the first tailor who cut and made men’s clothes.”¹⁴⁰⁶

“In January, 1805 [sic], Rufus Williams (spoken of before as one of the first settlers) was instantly killed by the fall of a tree blown down upon him in a high

wind, as he went out to fodder his cattle.”¹⁴⁰⁶

- “[These settlers in the town of Huntington about 1789], were closely followed by Thomas and Rufus Williams, who each pitched next to John Martin on East Hill, the one north and the other east of him.”¹⁴⁰⁷

- 1789 About this time Thomas and Rufus Williams settled on East Hill; Abel Turner, John Fitch, and Samuel Fargo in the Buel’s Gore section of town; and Stephen Squires in Sherman Hollow.¹⁴⁰⁸

- Know all Men by these Presents –

That I, Jonathan Spafford, of Williston, Chittenden County and State of Vermont. For the Consideration of Thirty pounds — Money Paid to my full Satisfaction by Rufus Williams of Huntington in Chittenden County and State of Vermont, have and hereby do fully give Grant, Sell and Confirm unto the said Rufus Williams, his Heirs and Assigns forever, a certain Piece of Land in Huntington as Described as Follows:

Lot No. 35 Surveyd to Silas (Nogges?) Containing one Hundred acres of Land, for [First Heirs P?] reference being had to the Survey Bill of said Lot.

To have and to hold Said Granted Premises, with all the Privileges and Appurtenances thereof, to the said Rufus Williams, his Heirs and Assigns, to his and their own issue and behalf forever, and I, the said Jonathan Spafford, for myself and Heirs, Executors, and Administrators, do covenant with the said Rufus that until the [Ensealing?] these Presents, I am the Sole owner of the Premises and that they are free from every Incumbrance, and I hereby Engage to Warrant and Defend the Same against all Lawful Claims whatever.

In Witness whereof I here unto set my Hand and Seal this 20th Day of January 1796.

On application of Jacob Williams of Huntington in said District, Adm. of the Estate of Rufus Williams, late of Huntington __?__ Deceased:

It is Ordered & decreed that unless the Creditors to the Estate of said deceased shall within Five Months from this day exhibit their Claims to said Administrator

for settlement, They be forever Barred. And that said Creditors be informed of this Order & decree by a Publication Posted up in the most Published place in Huntington & in Richmond both in the County of Chittenden as soon as may be, at the end of which time You are to make return ___?___ to this Court.¹⁴¹³

July 3rd 1804 Rec. the Inventory of said Estate to the Amt \$795.20.¹⁴¹³

- To the Honorable the Supreme Court of the State of Vermont now sitting at Burlington within and for the County of Chittenden –
The Petition of Jacob Williams of Huntington in said County humbly sheweth, that Rufus Williams late of Huntington aforesaid, died seized and possessed of one hundred acres of land in the town of Huntington afd [aforesaid?] being Lot No. 35 in the first Division of the right of Benjamin Cornell an original proprietor in said Town, leaving minor heirs, to wit, Elisha Williams, Phebe Williams, and Harry Williams, and that your petitioner is the Guardian to said minor heirs duly appointed by the Honorable Solomon Miller, Esq., Judge of Probate for the district of Chittenden. Your Petitioner further sheweth that it would advance the interests of said minor heirs to sell, dispose of and deed said Land. Therefore prays this Honorable Court for an order empowering him the said Jacob Williams to sell, dispose of and deed the same; and your petitioner as in duty bound will ever pray.

• Know all Men by these presents, that I, John Butler, of the Town of Huntington, County of Chittenden and State of Vermont, do for the Consideration of six hundred and fifty dollars to me in hand paid by Jacob Williams, Administrator of the Estate of Rufus Williams, deceased, of the town, county, and state aforesaid, the receipt I do hereby acknowledge for which I have given, granted, bargained, sold, and by these presents, do give, grant, bargain, sell, [unknown] convey and confirm unto him this said Jacob Williams, Administrator of the Estate of Rufus Williams, deceased, who was Impowered by the Decree of the Probate Judge to act wholly for the heirs of said Rufus Williams, deceased, a certain tract or parcel of land, lying and being in the Town of Huntington, County of Chittenden, State of Vermont.

Berthed and bounded as follows: Beginning at a stake and stones, being the NorthEasterly corner of John Thomas' land, thence S 28° to 160 rods to a beach tree being the Southeasterly corner of John Martin's land, thence S 62° & 100 rods to a stake and stones, thence N 28° & 160 rods to a stake and stones, thence a straight line to the first named bound, and containing 100 acres of land and [blank] to the original right of Benjamin Cornell.

To have and to hold the same with all the privileges and appurtenances thereof unto made him the said Jacob Williams, Administrator of Rufus Williams, deceased, to him his heirs and assigns forever. And do hereby covenant to and with the said Jacob Williams, his heirs, estate administrators and assigns that the premises are free and clear of all encumbrances, and that I will warrant and defend the same against all demands whatever. In witness whereof I have hereunto set my hand and seal this 7th day of May, 1807.

Provided nevertheless that if the said John Butler doth well and truly pay or cause to be paid unto Jacob Williams or his Assigns five Custom Notes of hand bearing date the 23rd February 1807, in Consequence of the Bargain Contract and Sale of the premises to be understood [?] his Interest took its rise from this date the 23rd February the principal Notes are five One Hundred and Twenty Dollars each payable in Meat Cattle at the House of Elijah Peaks in Hinesburg on the 4th day of October, the first Note payable 1807, and so on the 4th day of Oct. 1808, 1809, 1810, 1811 together with five Interest Notes bearing the same date namely the 23 February and are correspondingly agreeable to the foregoing dates, one of

thirty-six dollars, one of twenty-eight dollars and eighty cents, and one of twenty-one dollars and sixty cents, one of fourteen dollars and forty cents, and one of seven dollars and twenty cents, and furthermore, in case of my failure in any payment, at any period of time, he the said Jacob Williams shall have full right to reenter the premises and use, occupy, and possess, and enjoy the same but in case the payments are duly made at their respective dates, then this Instrument is null and void. Otherwise in full force and Virtue in the Law.

- Paul Williams was almost certainly the brother of Rufus; family tradition according to “Chotty” [McMorran] is that Paul's children/grandchildren were frequent visitors at Miron Williams’ home in Michigan.⁹⁶
- “Chotty’s” notes indicate no proof of the parentage of Paul, Rufus and Prudence.¹³⁹⁵

- Under the State Constitution of 1802 up to 1825 it was only known as Portage township, at which time Gen. Simon Perkins and Paul Williams platted and laid out a town upon and surrounding the intersection of Main and Exchange Streets in Uppertown, and, it being on the top of the summit, at an average of 400 feet above the Lake, called it Akron.¹⁴²¹

- He [General Perkins] did not, however, own all the land at the exact spot where he felt the town should be located. A section southeast of Main and Exchange was owned by one of the first settlers of Portage Township, Paul Williams, a native of Connecticut.

Williams had come to the Reserve in June, 1811, with Miner Spicer, of Groton, Conn., and the two men had selected sites where they decided they would like to settle. During the following winter, on February 12, 1812, Williams and Spicer bought adjoining tracts in Tract 8, Portage Township, from Joseph Perkins. Williams paid \$273 for 109.13 acres, or \$2.50 an acre.

After acquiring his land, Williams brought in his family, built a log cabin near the present intersection of Buchtel and Broadway, and began farming.

Agreeing on the town-founding plan, Williams and Perkins quickly came to terms and in the late spring of 1825 the two men employed Joshua Henshaw to lay out a town. Williams owned approximately a third of the town site; General Perkins owned the remainder. Each man retained title to his portion.

For some unknown reason, Williams had nothing named for him to perpetuate his memory. This may have been because he died soon after the town was founded, on May 17, 1828, and his properties were divided among his many heirs.¹¹²

- Williams, who had come to Portage Township with Miner Spicer in 1811 to select land for homes, purchased his tract, containing 109.13 acres, from Joseph Perkins on February 6, 1812, for \$273, or \$2.50 an acre. On the same day, Perkins sold Spicer 260 acres adjoining Williams' tract on the east, for \$650.

Williams and Spicer became the first settlers of Portage Township. Williams built his home at what is now the corner of Broadway and Buchtel Avenue while Spicer built near the present corner of Exchange and Spicer.¹¹²

- Previous to the commencement of work upon the Ohio Canal, in 1825, the

territory now covered by the thriving and populous city of Akron was an almost unbroken wilderness, excepting a small portion of the Sixth Ward (the original village of Middlebury) and the partially cultivated farms of Miner and Amos Spicer and Paul Williams, these gentlemen being the first settlers in Portage township.²⁵⁸

- When the commissioners decided to run the canal across the portage, General Simon Perkins of Warren (one of the commissioners) formed a partnership with Paul Williams, and bought up 1,000 acres for a trifling sum of money. They laid out the beginnings of Akron in 1825 and reaped a rich harvest. The Irish who came west to dig the canal put up a hundred cabins in the village. In 1827 when the canal was opened about 600 people were living in Akron. It was in the Reserve, but it was in no wise New Connecticut.¹⁴²³

- The farm house of Paul Williams, a one story frame building, on the laying out of the new village, was found to stand in about the center of South Broadway, a little south of Middlebury street, and was accordingly moved a few rods to the eastward, where, as the well known Babcock house, it still stands, in a remarkably fair state of preservation.²⁵⁸

- Leaving Groton again in June of 1811, with the sturdy conveyance of an ox team and wagon, and this time accompanied by his family, his brother Amos, and Paul Williams, he [Major Minor Spicer] once more reached the spot that was for more than twoscore years to be his home.²⁵⁷

- For a time, Minor Spicer, Amos Spicer and Paul Williams, with their families, constituted the entire settled population of the township.²⁵⁷

- The first settler in the Akron territory outside Middlebury was Major Miner Spicer, who laid out a 260-acre farm in what was later "Spicertown," in 1810, and settled there the following year, after a four-month trip from Groton, Conn., by ox team. With him were his wife, his brother Amos and his cousin, Paul Williams. This same cousin, Paul Williams, was to be the first settler in the original town-site of Akron. But this was not until the next decade.⁵⁰⁸

- In the following June, he [Miner Spicer] again started for Ohio, this time with

his family. He was accompanied by his cousin, Amos Spicer, and Paul Williams who had purchased a 109-acre tract immediately west of his land. The party, traveling by ox cart, did not arrive in Portage Township until September.¹¹²

- The year following his wife's death, Major Spicer married her sister, Hannah Allen, widow of Barnabus Williams. Her husband may have been the son of Paul Williams, who also came as early as 1811.¹³³⁷

- Paul Williams, one of the founders of the original town of Akron, was a native of Connecticut who came to Portage Township in 1812 with Miner Spicer after having purchased a 109-acre tract from Joseph Perkins, of Groton, Conn., for \$2.50 an acre.

Mr. Williams built a log cabin at what later became the corner of Buchtel Avenue and Broadway and engaged in farming.

In 1825, Mr. Williams joined with General Simon Perkins in founding Akron, approximately one-third of the original town site being his land.

Mr. Williams died on May 17, 1828. He was survived by his widow, Sarah; two daughters, Clarissa (Mrs. George Babcock), and Hannah; and a number of grandchildren including Horace Weston, and Oliver S., Eliza and Eunice Williams, children of his deceased son, Barnabas Williams.

On one of the earliest maps of Akron, a short street between Main and the Ohio Canal, south of Exchange, was named Williams Street, but for some reason now unknown the name of this street was later changed to Orleans.¹¹²

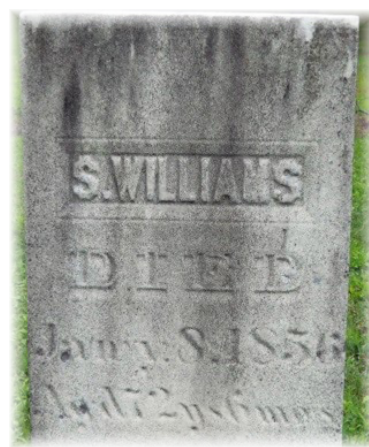

My Good Young Lady:

I regret to say that with all its pretensions to commercial, financial and industrial enterprise and such, Summit County is without an organized historical society, nor can even the "tip-top" city of Akron boast of such an institution. Hence your letter addressed to the secretary of said suppositious society has been sent to me, probably because of my modest pretenses to local historical lore. I fear, however, that I can throw but little light on the decidedly shadowy subject you are investigating, though familiar with the locality and many members of the families involved for the past 64 years. Mr. Hiram J. Spicer, youngest son of Major Miner Spicer, born here in 1816, is still living on a portion of the land purchased by his father for himself and others in 1810. Mr. Spicer says that the entire party who, with his father, settled on these lands in 1811, including Paul Williams, were from Groton, New London Co., Conn. But he does not know anything of the Williams ancestry, or the maiden name of Mrs. Paul Williams. Possibly the Town records of Groton could shed some light upon the subject.

Paul Williams, himself, died sometime before I came to Akron, 64 years ago. At that time his widow (second wife, I think) was living in the old homestead (still standing) and with her living a pair of twin granddaughters who had been orphaned by the early death of both of their parents. Their names were Adaline and Emeline Williams. The former married Samuel B. Axtell, of Richfield, in this county. A son, in Richfield, and a daughter, in New Jersey, survived them. Emeline Williams, never married, and is still living with her niece, I think, in Rahway, N.J.

A daughter of Paul Williams became the wife of Mr. George Babcock, and succeeded to the homestead, on the death of the mother. A son of the Babcocks, Williams P. Babcock, now 64 years of age, is still living here. I have interviewed him, but he can give me no information that will be of any practical worth to you in your research. He thinks there is a family record in existence, possibly in possession of a sister-in-law in a neighboring town which he will try and hunt up. If he finds anything of value to you I will advise you later. Mr. Babcock

thinks that his cousin, Emeline Williams, knows more about the early history of the family than any other person now living. Her P. O. address, Mr. Babcock thinks, is 127 Church St, Rahway, N.J.

There are other descendants of Paul Williams still living here, among whom a great granddaughter, Mrs. Judge A. C. Voris of 243 Fir St., may possibly have given the subject you are investigating some attention in quest of (discovering ?) antecedents in her own behalf. Possibly a line to her may prove beneficial to you. Regretting my inability to serve you better, and believing that you will the more fully appreciate the little I have attempted to do when I inform you that I am now in my 85th year, and so nearly blind as to be unable to read this letter after I get it completed, I am

- **MIRON WILLIAMS**
1813-1884

Born in Bennington, Vermont. Died in Marysville, Michigan.

When he was three years old, his parents moved to Deerfield, Ohio. When he was 17 years old, he started working as a carpenter in Canton, Massillon, and Cleveland. In 1832, he moved to St. Clair county, Michigan, and began his career as a millwright, at which trade he built more sawmills than any other millwright in the state.

As time went on his occupation changed to producing lumber from the pine forests of the state. During the latter part of his lumber operations, he and Nelson Mills were partners in an operation at Marysville. He disposed of his lumber interests in 1875 and retired to his farm on the bank of the St. Clair River immediately south of Marysville.¹

- Came to Newport in 1832 and joined with Sam Ward and William Gallagher operating saw-mill and grist mill at Belle River Mills, then known as Ward & Gallagher Mills.

Married Mary Gallagher, 1838.

Settled in Vicksburg, 1854.⁵⁴²

- Two brothers, J. L. and J. W. Kelsey, built a mill in 1844 in the forest three miles west of Vicksburg on the Fort Gratiot Turnpike. Their lumber was hauled by teams to their dock up the St. Clair river which was known as Kelsey's dock or wharf.

Miron Williams and Nelson Mills organized a partnership March 21, 1850 and bought the mill and adjoining land of Kelseys. They operated the mill under the name of Williams and Mills, later to become a well known institution along the river and at Vicksburg, to which point the Kelsey mill was moved in 1858, after the timber available to the turnpike mill was exhausted.

Miron Williams had been a mill operator for Ward & Gallagher at Belle River Mills. Nelson Mills had been since 1844 a ship carpenter in Ward's Marine City Shipyard. Williams married the oldest Gallagher girl, Mary, in 1838 and they came in 1854 with their family of two boys and seven girls to Vicksburg, this being quite a substantial increase in the population of that time. The Williams farm home became the scene of much entertainment during the 30 years following. A school was maintained by Williams for his own children and those of the neighborhood, being the first school house in Vicksburg.¹¹²⁹

- MIRON WILLIAMS, capitalist, Marysville, is a native of Bennington County, Vt., and was born in the town of Bennington June 6th, 1813. When only three years of age his parents came to Ohio and located on the Western Reserve. He lived there until seventeen years of age, then worked at carpenter trade at Canton, and Massillon and also at Cleveland. While at the latter place he hired out to a millwright, named Wells, for three years. In June, 1832, he came to St. Clair County on the old steamboat Gratiot and landed at Uncle Billy Brown's place on the river. He began working at his trade. The same year helped build the old Black River steam mill. Built several mills in Canada and many in this State. He built more mills while in the business than any other millwright in the State. He bought out and ran a saw mill, grist mill and carding mill at Detroit and was there two years, then returned to Newport. He was there but a short time when he engaged more extensively in the lumber business; bought a large amount of pine land; bought one mill and built another at Marysville and an

interest in another at Algonac; had lumber yards in Huron, Fremont, Toledo, and Chatham, in Canada, and also shipped to Chicago and transacted a large and extensive trade, owning from eight to ten thousand acres of pine land, and during his business life lost a large fortune by fires and by the failures of others. He continued in the lumber business until 1875. Disposed of his pine and lumber business and retired to his farm on the river where he now lives. He is one of the oldest settlers in the County, and his success in life is owing to his own efforts. Mr. Williams married Miss Mary Gallagher, of Belle River, this County, in February, 1838. They had ten children — William (died when two years of age), John G. (was killed in the lumber woods January, 1870, he was thirty years of age), Mary (now Mrs. N. Mills), Hannah (now Mrs. C. Neal), Emma (now Mrs. H. McMorran), Prudence (now Mrs. C. Dale), Florence (now Mrs. G. Kimball), David (married and living in Port Huron), Adaline (at home), and Emeline (now Mrs. A. J. Beardsley).²⁹

- In 1859, Myron Williams was successful in changing the name of the community from Vicksburg to Marysville (in honor of his wife and daughter whose names were Mary).⁵¹⁶⁵
- Justice of the Peace, 1879.²⁹
- Myron Williams, father of Emma Caroline (Williams) McMorran, was b. in Vt. He moved to Ohio when a young man, and later to Mich., where he engaged in lumbering in the Thumb Dist. He was a millwright contractor and built sawmills throughout the state, including one at Marysville, Mich. His wife, Mary (Gallagher) Williams, was b. in Pa. (?).¹⁰⁵⁹
- Myron Williams, of Marysville, died at the residence of his daughter, Mrs. Capt. Neal, in Ann Arbor, last Friday. He went to that city about two weeks ago to secure medical treatment, but his condition was hopeless, and suddenly terminated in death.

He was born in Bennington, Vt., on June 6th, 1813, and was 71 years old when he died. He came to St. Clair county in 1832, and settled in St. Clair township. He was a millwright, and built a very large number of mills in this state and Canada. He also engaged in the lumber business, and carried on extensive trade.

He was married to Miss Mary Gallagher, of Belle River, in February, 1838, and she died one year ago. Ten children were born to them — William (died at two years of age); John G. (killed in the lumber woods in 1870), Mary (Mrs. N. Mills of Marysville); Hannah (now Mrs. Neal of Ann Arbor); Emma (now Mrs. H. McMorran of Port Huron); Prudence (Mrs. C. Dale), Adeline (with her father), Emeline (now Mrs A. J. Beardsley of Charlevoix); Florence (now Mrs. Guy Kimball of Port Huron); and Mr. David Williams, of Port Huron.

The funeral was held on Sunday morning and the body was interred in the cemetery at Belle River, near St. Clair city, where his wife was buried.¹⁴³³

• Paul Williams himself died sometime before I came to Akron 64 years ago [thus 1835]. At that time his widow (second wife, I think) was living in the old homestead (still standing) and with her were living a pair of twin granddaughters who had been orphaned by the early death of both of their parents. Their names were Adaline and Emeline Williams. The former married Samuel B. Axtell, of Richfield, in this county. A son, in Richfield, and a daughter, in New Jersey, survive them. Emeline Williams never married and is still living with her niece, I think, in Rahway, N. J.¹⁴¹⁸

• I have been doing quite a bit of investigation on the West Richfield connection. I have been to Richfield twice and collected some information there.

The first bit you might find of interest is that Adaline apparently separated from Samuel Beach before he went to Utah. She went back to Ohio and began buying land in West Richfield. At her death she apparently owned quite a bit. It was in her name, not in S.B.'s. I couldn't find out how it was disposed of, except that some went to Roscoe. Charles Clifford had a small piece that that she apparently gave him while she was still living.

She is NOT buried with him in New Jersey. She is buried in Akron, along with Charles Clifford and Mary. Apparently Mary died first and C.C. lived in Akron with his brother Lewis until his death. From your account it appears that Lewis

then went to Pennsylvania to work.

A large part of the land that Adaline owned in West Richfield was later taken over by the Girl Scouts as a camp. The GS are now trying to sell it. The Richfield Historical Society is trying to raise money to buy it as they don't want it to be divided up for housing.⁷³¹⁸

- Mrs. Adeline Axtell, widow of the late Hon. Samuel B. Axtell, who died about a year ago, departed this life at Richfield, Ohio, July 19th.⁷⁸¹⁶

- Application has been filed in the same court for the admission to probate of the will of Adaline S. Axtell, late of Richfield township. All of the property of testatrix is left without reservation to her daughter, Alice Phillips, and husband.⁸²¹²

Dear Sir

Your letter in relation to some money now in your hands as Administrator of Sanford Williams Estate, due to his daughter Adaline now my wife, has been duly Exd by us. We desire this money to be paid to my wife's sister Emeline Williams.¹⁴³¹

- Hon. Samuel B. Axtell, one of Richfield's early adopted sons, and whose family and property interests are still in that township, represented the San Francisco (Cal)., district in the fortieth and forty-first sessions of Congress. Returning to Richfield, on the expiration of his second term, he was in January, 1875, appointed governor of the territory of Utah, by President Grant, but a few months later was transferred to New Mexico, of which territory he was governor between three and four years. Still later, in May, 1882, by appointment of President Arthur, he became chief justice of that territory, which position he filled with acknowledged ability for three years, tendering his resignation to President Cleveland, May 1st, 1885, to take effect on the 25th of the same month. On June 1, 1885, Judge Axtell accepted from the Southern Pacific railroad, the position of solicitor of that road for New Mexico, with headquarters at Santa Fe, which position he held until his death, at the home of his daughter, Mrs. Charles M. Phillips, in Morristown, New Jersey, August 6, 1891, at the age of 71 years, 9 months, 22 days.²⁵⁸

- [excerpts] In 1851 he went from Richfield [Ohio] to California, and his wife

followed and joined him there in 1856. In California, he was a practical miner and laborer, working with all his might at whatever his hand found to do, and continuing the study of law, which he had commenced before leaving Ohio. He was admitted, upon examination, to the Supreme Court of the State of California in 1854, and commenced the practice of law in Jackson, Amador Co., in that State. He was three times elected District Attorney. Removing to San Francisco, he was elected, in 1867, to represent that city and district in the Fortieth Congress, and was re-elected to the Forty-first Congress.

In January, 1875, he was appointed by Gen. Grant Governor of Utah Territory, and in the summer of that year was transferred to New Mexico, where he acted as Governor for three years and a half, assisting during two Territorial Legislatures to obtain much needed and progressive legislation.²⁵⁷

- After President Grant appointed him governor of Utah Territory, one of Axtell's first acts was to deliver a certificate of election to George Q. Cannon, newly elected territorial congressional delegate. It was something Gov. Woods [his predecessor] refused to do. Axtell was immediately branded as a tool of the Mormons, and editors of The Salt Lake City Tribune referred to him as "Bishop" Axtell. He tried to ease the situation by touring the larger counties in the territory, but his opponents would have none of it and increased their attacks on him. In the end, Grant was asked to intervene, but instead he appointed Axtell governor of New Mexico Territory.²⁶⁶²

- The President and Secretary of the Interior have decided to dismiss the charges against Gov. Axtell, of New-Mexico, as vague and unsupported by proof. The Secretary, in the presence of the President and others, this morning expressed his intention of putting this decision on record as the result of a careful investigation made under his supervision by Assistant Attorney-General Marble. The charges, it is declared, were preferred by irresponsible persons who do not sustain them under oath. On the other hand, Gov. Axtell denied the charges promptly under oath and furnished official documents fully refuting them. In addition to this, an unqualified endorsement of his administration has been forwarded to the department from the best citizens of all parts of New-Mexico.²⁶⁷³

- Axtell was appointed Governor by President Grant in 1875. Axtell's

administration ended in 1878 when he was suspended by Secretary of the Interior Carl Schulz following an investigation into his activities as governor. He later became Chief Justice of the New Mexico Territorial Supreme Court.²²⁹⁸

- b. Oct. 14, 1819, married Adaline S. Williams of Summit Co., Ohio, Sept. 20, 1840. In 1843 he moved to Mt. Clemens, Mich. We have from the pen of Ralph Emerson Twitchell the following:

Samuel Beach Axtell was born in Franklin County, Ohio, October 14, 1819. An ancestor was an officer in the Revolutionary army and his grandfather was a Colonel of a New Jersey regiment during the war of 1812. His father was a farmer. Governor Axtell was a graduate of the Western Reserve College at Oberlin and was admitted to the bar in Ohio. In 1851 he went to California and engaged in gold mining and upon the organization of counties of the state was elected district attorney of Amador County. He removed to San Francisco in 1860, was elected to congress in 1866 and 1868 as a democrat. He changed his political faith at this time and allied himself with the Republican Party of which he was a staunch supporter to the time of his death. In 1874 he was appointed governor of Utah by President Grant and in the following year was transferred to New Mexico, being inaugurated governor July 30, 1875. He was superseded in this position by General Lew Wallace [author of Ben-Hur], appointed by President Hayes in 1878. In 1882 he was appointed chief justice of the Supreme Court of New Mexico, assuming the duties of the office in August of that year. In 1885, Grover Cleveland having been elected president, he resigned the office in May of that year. He was a man of high principles, absolutely without fear. On the bench he endeavored at all times to secure what he saw fit to designate as "substantial justice" for all litigants, and judicial precedents which interfered with the main object of trials in his court, or with equity from his standpoint, were ruthlessly cast aside. In 1890 he was elected chairman of the territorial republican committee. He died August 7, 1891, at Morristown, New Jersey. Conditions, methods, and practices obtaining in the courts of New Mexico during Judge Axtell's incumbency, and the fearless character of this jurist are well exemplified in the relation of incidents occurring in one or two cases tried before him. In a celebrated criminal trial at Las Vegas, although Judge Axtell had been warned that his life would be forfeited if he dared to sit in the case, promptly on time he

opened court. On this occasion he compelled the sheriff to search all of the court attendants and the spectators before he allowed the case to proceed. As a result forty-two revolvers were piled on the table, some having been taken from the attorneys in the case. Each man carrying a weapon into the courtroom was fined ten dollars for contempt of court, and no show of resistance was made when the fine was collected. In another case before him the defendant, a poor young man, whose farm was in jeopardy, had no attorney. Seeing that the case was going against the man unless he could obtain legal counsel, Judge Axtell descended from the bench and began conducting the cross-examination with the remark: "It takes thirteen men to steal a poor boy's farm in New Mexico." Upon the conclusion of the submission of evidence, he instructed the jury to find a verdict in behalf of the defendant. When the foreman announced a disagreement, the judge discharged the jury, announced a verdict in behalf of the defendant, and told the sheriff never to allow any one of the discharged jurymen to serve again in Miguel County. His wife died in July 1893.²⁶⁶⁴

- AXTELL, Samuel Beach, a Representative from California; born near Columbus, Franklin County, Ohio, October 14, 1819; attended the local schools and Oberlin College; was graduated from Western Reserve College, Hudson, Ohio; studied law; was admitted to the bar in 1843 and commenced practice in Mount Clemens, Mich.; went to California in 1851 and engaged in mining in Amador County; prosecuting attorney of Amador County 1854-1860; moved to San Francisco in 1860 and practiced law; elected as a Democrat to the Fortieth and Forty-first Congresses (March 4, 1867-March 3, 1871); was not a candidate for renomination in 1870; affiliated with the Republican Party during the administration of President Grant; appointed Governor of Utah Territory in 1874 and subsequently, in 1875, transferred to the office of Governor of the Territory; chief justice of the supreme court of the Territory of New Mexico from August 1882 until his resignation May 25, 1885; engaged in the practice of law in Santa Fe, N. Mex.; at the time of his death was counsel of the Southern Pacific Railroad Co. and chairman of the Republican Territorial committee; died while on a visit to Morristown, Morris County, N.J., August 6, 1891; interment in First Presbyterian Church Cemetery.²³⁴⁵

- US Congressman. Elected to represent California's 1st District in the United States House of Representatives, he served from 1867 to 1871. He also served as Governor of Utah Territory in 1875, Governor of New Mexico Territory from 1875 to 1878, and as Justice of the New Mexico Supreme Court from 1882 to 1885.⁵²⁸¹
- Mrs. Adeline Axtell, widow of the late Hon. Samuel B. Axtell, who died about a year ago, departed this life at Richfield, Ohio, July 19th. Samuel B. Axtell was an old-time attorney of Amador county and was elected to the office of District Attorney in 1854, at the first election after the county of Amador was set off from Calaveras. He was re-elected to the office again in 1856. He lived in Jackson till 1864, when he went to San Francisco. Being a natural leader and a politician, in 1867 he received the nomination for Congress from the First District and was elected, defeating T. G. Phelps. In 1868 he was again elected to Congress, this time defeating Frank M. Pixley.⁷⁸¹⁶

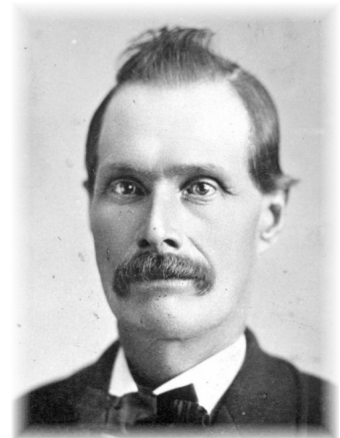

- [excerpts] Lumbering reached gigantic proportions back in our early history, when Michigan was known as the lumber capital of the world. Ogemaw County contributed millions of feet of virgin timber during that era, which has acclaimed Michigan a giant in the annals of our history.

In the fall, when the first snow came, the Mills family's horses and oxen were shipped from Stag Island in the St. Clair River to Ogemaw County to work in the lumber camps.

Around 1870 the Mills family owned hundreds of acres of Ogemaw County. They started a lumbering project which was carried for twenty years. After the trees were cut and trimmed into sizable logs, they were skidded into the Rifle River, during the spring freshets, and floated downstream. Upon reaching Lake Huron, they were rafted and pulled by tug boats to the St. Clair River, near Port Huron. Steam boats and tow barges transported them to Cleveland, Ohio, through Lake Erie.³⁴⁰²

- Mills Township, with the Rifle River flowing through its center, is surprisingly free of early lumber settlements. Although lumber camps surely existed along the township's waterways, supply and milling settlements flourished elsewhere.

Richland Township contained the settlements of Hardwood Lake and Mills, and is still the location of the village of Prescott. Mills was a train stop at the western county line. Prescott began as a camp called Camp Six. Its owner, Barney Mills, built a saw mill and shingle mill and owned much of the timber lands in Mills and Richland Townships.³⁴⁰³

Prescott's first saw mill was built by Barney Mills. He also built a shingle mill in Prescott. In 1889, the McLain brothers owned the mills that Mr. Mills had built.³⁴⁰³

John Fitzmaurice tells of a Saturday evening he spent in a southern Ogemaw Camp.

January 17th, 1883, I find by reference to my notebook, was an occasion in which I was made partaker in a camp "Saturday night" that I will long

remember. It was in B. B.[sic] Mills' Rifle River camp, Mich., which like a singed cat, was much better than it looked. It was built upon the old-fashioned style, with what is known as a "caboose," in place of a stove. The "bunk camp" was cosy, and with but little room, one would imagine, in which to give a variety theatre exhibition. Still, in that same camp was congregated more diversified talent, than I have met at one time before or since in the woods.³⁴⁰³

- The Mills Transportation Company was formed February 4, 1878, with a capital stock of \$250,000, divided into 10,000 shares of \$25 each. Nelson Mills, of Marysville, held 2,812; Barney Mills, 938; August C. Gray, 1,250; Henry McMorran, Port Huron, 2,500; and Charles Neal, Bay City, 2,500 shares.²⁹

- **Prominent Port Huron Man Dead.**

Port Huron, Mich., July 19 [1905] – Barnabas Mills, a brother of the late Nelson Mills and a partner of his in many of their business enterprises, died at this home at Marysville this morning, aged 77 years. Mr. Mills took sick while inspecting some of the lumber properties belonging to the estate in northern Michigan, and was brought home last week.¹¹²⁸

- Died intestate.¹¹³⁵

- Barney Mills died intestate leaving a widow without children by him. The widow has one son and two grandchildren by a former marriage. There are thirteen families of Barney Mills kindred of which the heads of six are still living. Two near Chatham, Ontario, one in Washington state, two in Ogemaw County, Michigan, and one in this village. Of all the other families there is one minor child about sixteen years of age living near Chatham, Ontario.

- In a separate email I am going to send you a photo of the first store in Prescott, which was built by Barney Mills as a general department store. The two-story brick building was built sometime before 1900 on Sherman Street. Mills closed the store and the building was purchased by the I.O.O.F. and Geneve Rebecca Lodges. The groups held their meetings upstairs and used the first floor for large gatherings, such as banquets, dances, and large community meetings. For quite a number of years (about 15) the first floor was also used by the school where temporary classrooms were established. After 1965, when the I.O.O.F. charter expired and was not renewed, the building was sold to Bud and Bernadine Haskin and used as a recreational facility.

Do you have the book called PRESCOTT COMMUNITY IN PIONEER HISTORY by Ervadeen Hosbach?⁶¹¹⁹

- Barney Mills was another pioneer lumberman. He owned hundreds of acres of wooded land north of town. After the land was cleared it was sold to men who became farmers. Mills also had one of the first general stores before 1900 in the two-story brick building on Sherman Street, which now houses Bud and Bernadine Haskin's Rec. Hall.⁶¹⁴⁶

- The town had several mills as well as in the rural area. Barney Mills had a grist mill and Bob Cliff, Sr. had a shingle mill. Both were destroyed by fire.⁶¹⁴⁶

- Harold Currie lives on the farm of his grandfather, Gilbert Currie, Sr., two miles north of Sage Lake Road. It had been purchased from Barney Mills.⁶¹⁴⁶

- Yesterday I spent some time at the Oscoda library in the genealogical room. (I love it there!) Anyhow, I found some little things about Barney Mills in the newspapers. I figured this was easier to just type the info out rather than scan the

copies, as some are such poor quality.

TAWAS HERALD June 5, 1891: Barney Mills long timber camp is in operation at West Tawas, again with Joseph Lalone, the old standby foreman. Part of the old crew is on deck, with Tink at the helm.

TAWAS HERALD May 20, 1892: (two entries)

Louis Grant, representing E. Morse, the lumber King of the east, of Tonawanda, was in town this week visiting Jos. Lalone, Barney Mills' foreman. Mr. Morse has purchased a quantity of timber from Mr. Mills.

Jas. Lalone, foreman for Barney Mills, informs us that he has started rafting at the mouth of Tawas River, and will add another force of men in a few days. Quite a number of the old boys are at their old posts of duty.

TAWAS HERALD July 28, 1893: (part of the Prescott social column)

A train of Barney Mills long timber goes out every day from Bush Lake to Tawas Bay.

J. B. Mills, better known as "Cheap John," handles hardware and everything very extensively. He keeps in stock hardware from a needle to a threshing machine. J. B. is quite a hustler.

TAWAS HERALD December 15, 1893: (part of the Prescott social column)

The Keystone flouring mill here is now owned by Messrs Barney Mills and C. E. Cannan. The third partner pulling out of the business.

TAWAS HERALD March 29, 1895: C. E. Cannon has served his connection with the Keystone Milling Co. Having sold his interests in the firm to Barney Mills.

TAWAS HERALD June 27, 1902: (part of the Whittemore social column)

Barney Mills visits our village quite often of late. He has a fine span of drivers of which he is justly proud, and then he is found of good company.⁶¹⁴⁷
